## STATUTORY OBLIGATION TO PAY CENTRE FEES

1. We hereby apply to have the child whose name appears on this form as a learner at PETERBRIDGE COLLEGE and confirm that he/she complies with the basic criteria.
2. I/We hereby certify that I/we have legal custody and/or guardianship in respect of the above-named learner.
3. I/We undertake to adhere to the PETERBRIDGE COLLEGE rules and disciplinary code and to the various alterations in the rules and disciplinary code that may be made from time to time.
4. I/We understand and confirm that the headmaster or any person duly authorised, will act in *loco parentis* in any matter and at any time during which I/we have entrusted our child to the care of PETERBRIDGE COLLEGE.
5. I/We understand that while every reasonable effort will be made to prevent losses or damage to learner's clothing and equipment, PETERBRIDGE COLLEGE cannot be held liable for such.
6. I/We undertake to reimburse PETERBRIDGE COLLEGE for any damage to College property that may be caused by our child.
7. I/We **jointly and severally (Irrespective of our marital status)** undertake to pay school fees and we/I understand the following:

The annual PETERBRIDGE COLLEGE Centre fees for 2026 will be as follows:

(i)	Grade 8	R33 600 per annum = R2 800 per month x 11
(ii)	Grade 9	R36 132 per annum = R3 011 per month x 11
(iii)	Grade 10	R36 480 per annum = R3 040 per month x 11
(iv)	Grade 11	Same as Grade 10
(v)	Grade 12	R24 960 per annum = R2080 per month x 11

Please note the following –

- R80 monthly surcharge will be levied for all students registered for CAT
- R50 monthly surcharge will be levied for stationery (printing paper and examination pads)
- Any student on reduced fees will be required to pay fees for full 12 months.
- Any account that falls into arrears will be charged for full 12 months

**Note: These fees exclude the cost of Impaq, stationery, uniforms and special outings**

- a. A non-refundable R1750 registration fee is to be paid prior to the learner being enrolled.
- b. College fees are to be paid in advance, by the 1<sup>st</sup> day of the month.
- c. If payment is not received by the 1<sup>st</sup> of each month, a grace period is given until the 10<sup>th</sup> after which the fees are in arrear and parents will be contacted by the College's administrative / finance department.
- d. Parents who are temporarily unable to pay school fees, should contact the finance department so that suitable and documented arrangements can be made.
- e. Where fees are still overdue at the end of the month, students may be suspended from attending classes until the arrears are cleared. This is not in the student's interest and should be avoided wherever possible.
- f. Interest on overdue accounts may be charged at 10% per annum
- g. In the event of non-payment of college fees, the College may hand the account over for collection. Both parents will be held liable irrespective of any maintenance or court orders which may exist between the parties. The costs of collection as well as the costs in attending to any rescission of judgement will be for the parents' account.
